VENDOR SPACES ARE NON-TRANSFERABLE. ALL VENDORS MUST SIGN AND RETURN THIS LIABILITY WAIVER ALONG WITH THE VENDOR APPLICATION FORM AND \$25 CHECK PAYABLE TO FOSRAS IN ORDER TO PARTICIPATE:

In consideration for being permitted by the Friends of Somerset Regional Animal Shelter ("FOSRAS") and the Somerset County Park Commission ("SCPC") to participate as a vendor for the above Shelter Walk, I hereby waive, release, and discharge any and all claims for damages for personal injury, death or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said activity.

This release is intended to discharge in advance FOSRAS (its officers, employees, volunteers and agents) and SCPC (its officers, employees, volunteers and agents) from any and all liability arising out of or connected in any way with our participation in said Shelter Walk, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks, I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above person or entities free and harmless from any loss, liability, damage cost, or expense which they may incur as a result of my death or any injury or property damage that I may sustain while participating in said Shelter Walk.

I hereby consent that my vendor group and its individual members participate in the above activity, and I hereby execute the above Agreement, Waiver, and Release on its behalf. I state that said group and its members are physically able to participate in said Shelter Walk. I hereby agree to indemnify and hold the persons and entities mentioned above free and harmless from any loss liability, damage, cost, or expense, which they may incur as a result of the death or any injury or property damage, that said group may sustain while participating in said activity. I HAVE CAREFULLY READ THIS AGREEMENT, WAIVER, AND RELEASE AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN FOSRAS, MYSELF, SAID GROUP and ITS INDIVIDUAL MEMBERS AND I SIGN IT OF MY FREE WILL.

- Event Date:** October 15, 2017 (RAIN or SHINE)
- Location:** Duke Island Park
In front of the Visitor's Center
189 Old York Road, Bridgewater NJ 08807
- 5K Run:** 9:30 AM shotgun start
5K Walk: 10:00 AM to 1:00 PM (walkers must complete walk by 2:00 PM)
- Vendor Check-In:** Immediately upon arrival see us at the Vendor Check-In Table. You will be notified of the location of your Vendor Space at that time
- Vendor Set-Up:** 8:00 - 8:30 AM
- Vendor Tear Down:** 2:00 PM (all vendors are requested to stay until the end of the walk)
- Vendor Space:** 10' x 10'. After set up, your car must be moved to the parking lot
